ORDER

Heard the representative of the PIO:

After Hearing the representative of the PIO and the Appellant, and after consideration of the above circumstances and pursuant to the relevant provisions of the RTI, Act, 2005, the Commission hereby orders as follows;

- (i) The PIO to provide the information(s) pertaining to DPR, UC, Photograph, Geotag, work progress reports, Departmental Cheque paid to the Contractors and remaining amount of unpaid Govt. funds of 17 projects as sought under Form-A application of the Appellant be furnished with the seal and sign of the PIO, on or before the next date of hearing.
- (ii) The Appellant to intimate the Commission about information received or not, on or before the next date of hearing.
- (iii) Formal notice need not be issued to the parties, as they are present during the hearing.

The Commission hereby orders;
