WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 96/2024**, your personal appearance is required before the Commission on **10th February 2026 at 01:30 PM**. The 2nd hearing held on **14th Oct'2025**, related to the APIC No- 96/2024. The Appellant Shri Tap Tapum Hiyang, present during the hearing in person but the PIO -cum EE (RWD) Jamin Division Kra-Dadi District Arunachal Pradesh, absent without reasons intimated to the Commission, despite notice for hearing served unto his office on 21/07/2025.

Heard the Appellant.

The Appellant stated that after the order of the Court of Arunachal Pradesh Information Commission(APIC) on 9/4/2024, directing the Superintending Engineer (SE) RWD, Yachuli Circle to conduct hearing of the PIO -cum EE (RWD) Jamin Division Kra-Dadi and the Appellant, for enabling the Appellant to get the information(s) that he has applied from the PIO.

On 17/06/2025, the First Appellate Authority (FAA) ordered the PIO to furnish the information(s) to the Appellant but, despite the order from the First Appellate Authority (FAA) the PIO has failed to furnish the information(s) to the Appellant and hence this 2nd Appeal of the Appellant before the Arunachal Pradesh Information Commission(APIC).

After hearing the Appellant the Commission hereby observes;

- i) The PIO despite the order of the First Appellate Authority has not bothered to provide the information(s) to the Appellant which is not in the interest of the RTI Act itself.
- ii) Despite the notice for hearing of the instant Appeal today, the PIO has failed to attend the hearing without informing the reasons for his absence.

Observing the above facts and circumstances the Commission hereby order;

- i) To send summons to the PIO to attend the next hearing without fail, **failing which the PIO shall be initiated action under section 20(2) as well as 25(5) of the RTI Act.**

- ii) The Appellant to be present in the next date of hearing. failing which, this appeal will be heard and determined ex-parte.
- iii) **The next date of hearing has been intimated to the Appellant.** Notice for next hearing need not be served to the Appellant as he is present in the court during the hearing.

The Commission ordered;

The next date of hearing be fixed on 10th Feb' 2026 at 1:30 PM (Afternoon).
