**Relevant facts emerging from appeal:**

The following were present: -

The appellant filed an RTI application dated 20.08.2024 Seeking information regarding implementation of AP State CAMPA funds for DFO, Bomdila forest division, West Kameng district (AP) from 2014 to 2024 and all kinds' reserved forests notifications in Bomdila forest division.

**Details of information required:**

- Projects wise Chart showing the enumeration of trees, species, and girth wise volume in respect of diversion of forest lands.

- ii. Projects wise statements showing number of trees volume and valuation of trees in respect of diversion of forest lands.
- iii. Projects wise detail estimates for departmental timber operation against extraction of trees in respect of diversion of forest lands.
- iv. Projects wise abstract of Royalty and Departmental timber operation.
- v. Projects wise detail estimates for creation of compensatory forestation for diversion of forest lands with maps.
- vi. Projects wise certificates from the competent authority regarding suitability area identified for compensatory forestation.
- vii. Projects wise site inspection reports.
- viii. Year wise amount receipts under AP State CAMPA from the office of PCCF, department of Environment, Forest and Climate Change, Itanagar, Govt of AP.
- ix. Year wise payment made with cheque counterfoils, money receipts and bank statements of DDO/DFO Bomdila forest division.
- x. All types of Reserved Forests Notifications in Bomdila forest division with minute of meeting and agreement copies.

Period for which information is required: 2014 to 2024

The following were present.

**Appellants** : Present (Nibo Pao & Adv. Tai Siva).  
States that no information is furnished in spite of order issued by the FAA– Chief Conservator of Forest, Western Circle, Banderdewa. They desires to obtain information pertaining to item ix in the RTI application only for the period from 2018 to 2024.

**Respondent PIO** : Represented by Kali Paja, RFO,  
He states that the information pertaining to item ix of RTI application shall be furnished to the appellant within two weeks from the date of issue of this order.

### **Decision:**

The Commission after adverting to the facts and circumstances of the case and hearing the parties observes that the appellant has not received all information. Now the appellant desires to obtain the information sought under item no ix in the RTI application only from the period 2018 to 2024. The PIO is directed to furnish the information pertaining to item ix in RTI application to the appellant on or before 21.02.2025 and file a file written submission of compliance to this commission court on or before 28.02.2025. The appellants are directed to file written submission to this commission court the status of information on obtaining the information

pertaining item ix of information sought in RTI application for the period from 2018 to 2024.

**Hearing adjourned.** Next date of hearing shall be fixed on receipt of compliance report of this order from the PIO and appellant.
