Summon Notice.

The 7th hearing was held on 29th **September, 2025** related to the **APIC No-1028/2023 (Appeal)**. Both the parties the appellant Shri Mamu Sono and the PIO-cum-EE, IMC Part-II, Naharlagun Er. Yumlam Take found absent without any intimation to the Commission.

The Petition dated nil has been received from Adv. K. Rimi praying for recall for or modify of penalty order passed against the petitioner as he had not received the summoned notices sent by the Commission. The petitioner also had submitted a documents stating the receipt of the summon notices dated 10/03/2025, 20/05/2025, 16/05/2025 and 13/10/2025 inspite of the receipt of notices as stated himself to the Commission. The PIO also stated that he has not received Form 'A' application but as per the case record it is seen that Form 'A' application was submitted to the PIO on dated 03/10/2023.

It is also seen that the First Appellate Authority has conducted a hearing on 19/09/2024.

Since, the appellant is also absent. PIO is given one more chance to deposit the penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only and submit a copy Challan to the Commission and also compensate an amount of Rs. 5000/- (Rupees five thousand) only to the appellant on or before next date of hearing.

If PIO is absent and fails to deposit the penalty amount, warrant of arrest under Section Order-XVI, Rule 10(3) CPC, 1908 R/W Section 18 (3) of RTI Act, 2005 will be issued against the PIO and thereafter, recommendation for Departmental Proceedings under Section 20(2) of the RTI Act, 2005.

The Commission fixed next date of hearing on 10/12/2025 at 2 PM.
