ORDER

The 1st hearing held on 13th March, 2025' related to the APIC No-405/2024. The Appellant Shri Mamu Sonu is present in person. The PIO of the office of the Director Land Management, Itanagar, Govt. of Arunachal Pradesh, is present through online mode during the hearing before the Commission.

Heard the Appellant:

The Appellant stated before the Commission that according to his Form-A application seeking information(s) for which the PIO has provided some of the information(s) but information(s) pertaining to S/Nos. c, d, f, i, j & k stated as not available.

The Commission Observes:

Whereas, the PIO should have furnished the reasons why those information(s) are not available in his office. The information(s) simply stated as not available be made available and the PIO to provide with whom the information(s) will be available and from where the information(s) not traceable be traced out.

After hearing both the parties during the hearing before the Commission/Court, the Commission hereby orders as follows:

- (i) The PIO to provide the information(s) pertaining to S/Nos. c, d, f, i, j & k to the Appellant on or before the next date of hearing, failing which necessary action shall be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (ii) The Appellant to intimate the Commission about information(s) received completely or not, on or before the next date of hearing.
- (iii) Notice need not be issued to both the parties as they are present in the court during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 3rd June, 2025' at 2:30 PM (A/Noon).
