2. The PIO to transfer the Form-A of the Appellant to the competent authority from where the Appellant can obtain the information.

3. The PIO to be present in the next date of hearing without fail, failing which necessary action against the PIO will be initiated as per the provisions of RTI, Act, 2005.
4. Notice be issued to the Appellant for the next date of hearing.

The Commission hereby orders;

The next date of hearing be fixed on 23rd day of April' 2026 at 10:30 AM (Morning).
