SUMMON NOTICE.

The 1st hearing was held on **11th February, 2026** related to the **APIC No-687/A/2025(Appeal)**. PIO-Cum-EE (PWD), Dirang Division attended the hearing through VC but the appellant Shri Tamchi Gungte found absent without any intimation to the Commission.

As per the case record, the First Appellate Authority has conducted the hearing on 30/07/2025 but the appellant was found absent. The responded PIO was present during the time of hearing. The document as sought by the appellant was brought before the FAA but could not handed over to the appellant due to his absence.

The appellant was directed to collect the information from the office of the FAA. The FAA also directed that if there is any short coming of the information provided the appellant should intimate within 15 (fifteen) days.

PIO stated that documents are still available before the FAA. Appellant is directed to collect the information from the office of the FAA and intimate to the Commission. If no intimation is made and found absent in the next date of hearing. the Commission will presume that the appellant is no more interested to pursue this appeal case and the appellant has received all the information and is satisfied.

Accordingly, the case will be decided in his absence.

The Commission adjourned the hearing and fixed next date of hearing on **8/4/2026 at 2 PM.**
