ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram & Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Chief Engineer (RWD)(PMGSY) Govt. of A.P, Itanagar as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 03.12.2024

A) Particular of information: To furnish information regarding Vibrant Village Programme Project 2024-25 under Kurung Kumey District (A.P)

B) Details of information required:

1. Total No. of project with the Sanction order copy;
2. Total list of tender participant in each project sanctioned under VVP;
3. Tender Evaluation copy of all tender participant of all the projects.
4. Tender winning firm against all the project sanctioned under VVP program;
5. Name of place where the tender process was conducted along with date and time;
6. List of the tender committee during the tender process;
7. The video recording/ coloring photograph of tender process/committee;
8. The note sheets submitted by the Local MLA, & CMO Office to award a tender work to the particular contractor participant as an election Liabilities and
9. Reason behind the delay of the tender result which was conducted on 14th March, 2024.

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellants, Shri Riya Taram & Shri Tamchi Gungte had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to file appeal before the Chief Engineer, (RWD) (PMGSY), Govt. of Arunachal Pradesh, Itanagar the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 14.02.2025. However, the appellants failed yet again to obtain the information and therefore, they preferred 2nd appeal before this Commission under section 19(3) of the RTI Act. 2005 vide their Memo of Appeal dt. 21.03.2025.

The appeal was, accordingly, listed and heard today on 30.07.2025 wherein one of the Appellants, namely, Shri Tamchi Gungte and the APIO, Likha Tei, Draughtsman are present in person.

The appellant submitted that the PIO had furnished the requested documents/information except the copies of sanction order. The APIO, however, submitted that the documents furnished to the appellant also include the copies of sanction order which are mentioned against each of the projects. He, however, submitted that more detailed clarification could be obtained from the EE of the Division concerned.

The PIO is directed to collect the detailed clarification from the Division concerned and furnish the same to the appellants within 30th August, 2025. The EE(RWD), Laying Yangte is also directed to furnish the clarification/explanation in writing to the PIO, o/o the Chief Engineer (RWD)(PMGSY), Itanagar in terms of the provisions of sub-section (5) of section 5 of the RTI Act.

This appeal is listed again on 05.09.2025.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 5th Sept., 2025 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
