**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Bengia Tani, on 20.11.2023 filed an RTI application under Form-A before the PIO-cum-Executive Engineer, PWD, Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh, seeking various information(s) regarding “ **All the work executed under Koloriang Sub-Division, PWD, Period from 2020 to 2023**”. Such as:

Brief fact of the case is that the Appellant, Shri Bengia Tani on **20/11/2023** filed an RTI application in form 'A' before the PIO-cum-Executive Engineer, PWD, Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellants being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **17/01/2024**. Appellants again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **17/05/2024** and the Registry of the

Commission (APIC) having receipt of the Appeal registered it as **APIC- No. 202/2024 (Appeal)** and processed the same for its hearing and disposal.

Accordingly this appeal came up for hearing before the Commission for 04 (four) times i.e on **24.09.2024, 14.11.2024, 21.01.2025 & 20.03.2025**. In the last hearing of the appeal both the parties were present in person before the Commission.

**Heard the Appellant:**

The Appellant informed the Commission that he has not received any information(s) from the PIO till date.

**Heard the PIO:**

The PIO stated before the Commission that he is not well versed about the matter as he joined recently as the PIO. Yet the PIO assured to provide all information(s) which are available in the office of the PIO.

**After hearing the parties: the Commission ordered as follows;**

1. The PIO to provide the information(s) pertaining to Serial Nos. **1, 2, 3, 4 and 5** to the Appellant on or before the next date of hearing .
2. Rest of the information(s) need not be provided by the PIO to the Appellant.

In the fourth hearing on 20<sup>th</sup> March' 2025, the PIO-cum-Executive Engineer, PWD, Sangram Division had assured to provide all the information(s) which are available in the office of the PIO to the Appellant on or before the next date of hearing.

Today, during the fifth and final hearing of the appeal on 05.06.2025 the Appellant is present through online mode but the PIO -cum-EE, PWD, Sangram Division, found absent without intimating the reason for his inability to attend the hearing.

The Appellant stated that despite the order of the Commission and assurance made by the PIO, the PIO has not furnished any information(s) to the Appellants till date.

Considering all the aspects into account the Commission find the PIO is liable to be imposed reasonable penalty under Sub-Section (1) of Section (20) of the RTI Act, and thus, the Commission orders against him as follows:

1. PIO shall pay a penalty amount of Rs. 25,000/- (rupees twenty five thousand) for his violation of sub-section (1) of Section- 7 of the RTI Act, 2005. The penalty amount shall be deposited through Challan payment in the name of Registrar, APIC, Itanagar, against the Head of Account No. 0070.
2. PIO shall furnish all information(s) sought which are available in the office of the PIO to the Appellants within a month from date of receipt of the order.
3. PIO shall submit all related records regarding payment of penalty including furnishing of information(s) to the Commission within one month of receipt the order.
4. Appropriate provision of RTI Act, 2005 will be invoked against the PIO in the event of his failure to comply with all or any of the above orders made against him.
