Previous Hearing:

First : 24.10.2025

Order of the 1st hearing- *"The Commission has observed that PIO did not deliver the information to the appellant irrespective of order issued on 27.06.2025 by the first appellate authority to do so. The appellant shall receive the information document from the representative of PIO today. The appellant shall file a written status report of full information received by him. If any shortcoming, the appellant shall file a written submission to the PIO specifying the shortfall within 10 days upon receipt of information under intimation to this commission. In case of no report received from the appellant within specified period this appeal case shall stands closed."*

The following were present.

Appellant : Absent.

Respondent PIO : Present. He has brought the information with him to handover it to the appellant. He has also informed that the said project is already cancelled by the NEC.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the PIO and perusal of the records, observes that available information is kept ready with the PIO. The appellant is directed to collect the information from the PIO within one week from the date of issue of this order and submit a written status report about information received from the PIO within two weeks from the date of issue of this order to the PIO with a copy to this commission i.e. **on or before 27.02.2026.**

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the appellant within stipulated time, this appeal case shall stand closed.
