Information sought:

The appellant filed an RTI application dated 19.12.2024 seeking following information regarding:

1. Furnish CTCs of lists of all the works taken up from various heads (State CAMPA, CSS, and State Plan) under Chowkham Forest Range from 2018-19 to 2024-25

2. Furnish CTCs of list of sawmills established under the jurisdiction of Chowkham Forest Range Namsai till date.
3. Furnish CTCs of list of Forest Reserves (Anchal Forest Reserve, Propose Forest Reserve, and Forest Reserve) under Chowkham Forest Range till date.
4. Furnish CTCs of seizure reports of all illegal timber under Chowkham Forest Range from 2019-20 to till date.
5. Furnish CTCs of lists of all the staffs (regular, Contractual and other) appointed and posted under Chowkham Forest Range from 2019-20 to till date.
6. Furnish CTCs of list of all the contractual staffs appointed and posted under the schemes State CAMPA under Chowkham Forest Range till date.
7. Furnish CTCs of list of Crushers established under Chowkham Forest Range till date along with copies of Noc issued for the same.
8. Furnish CTCs of list of Quarries along with copies NoC given issued for the same under Chowkham Forest Range bill date
1. Furnish of all the mining related industries/factories established under the jurisdiction of Chowkham Forest Range with date of establishment till date.

The following were present.

Appellant : Present. He states that he has received some information from the PIO but the information documents furnished to him do not conform to the items of information sought in RTI application. He further states that the FAA has heard the first appeal and passed an order directing PIO to furnish the information sought. Produced a copy of order passed by the FAA.

Respondent PIO : Shri H A Opo, RFO represented the PIO. He states that the available information has been furnished to the appellant.

F A A : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that FAA has heard the first appeal and passed an order dated 17.4.2025 directing PIO to furnish the information. The appellant submits that he has received information documents which is incomplete and does not conform the information sought in RTI application.

The appellant is directed to file a written submission to the PIO clearly specifying the shortfall in the information furnished to him within the purview of information sought in the original RTI application and obtain acknowledgement within one week from the date of issue of this order under intimation to this commission. The PIO shall furnish the information specified by the appellant within ten days upon receipt of such representation from the appellant and submit a written report to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant, this appeal case shall stand closed.


