**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Bamang Pacho, Near Main Power House, IG Park, House No. IMC 491, W-10, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Koloriang Division, Kurung Kumey District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 06/02/2025 regarding i. Approach road from BRO Helipad Lee to CO cum BDO resident via Hospota / general ground, ii. C/o WRSB over Rashik river and etc under Budget Estimate (BE) 2023-2024.
- 2). The 2<sup>nd</sup> hearing was held on 2<sup>nd</sup> December 2025. Shri Yomken Karga, the PIO-cum-EE( PWD), Govt. of A.P., Koloriang Division, Kurung Kumey District, Arunachal Pradesh was present and the Appellant Shri Bamang Pacho was represented by Shri Bamang Pacha.
- 3).The PIO had expressed his inability to trace the document, since he had not received any information post bifurcation of the Sangaram Division.
- 4).The Commission had directed the PIO to give justifiable reasons in writing through an AFFIDAVIT if the information were not available. Superintending Engineer, Yachuli Civil circle, PWD Arunachal Pradesh Yachuli was also directed to make arrangement to trace and furnish information to the Appellant.
- 5). The Commission had asked the Appellant to intimate his satisfaction or dissatisfaction after receipt of information.
- 6). The Appellant vide letter dated 19/12/2025 submitted that the PIO failed to furnish information as directed by the Commission and appealed the Commission for continuation of hearing.
- 7). The Commission to hear from the both the parties decided to fix a date of hearing.
- 8). **The next date of hearing is fixed on 3<sup>rd</sup> March'2026 (Tuesday) at 1100hrs.**

9).Therefore, the PIO-cum-EE (PWD), Koloriang Division, Kurung Kumey District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

10). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
