**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Licha Tabia & Shri Nabam Pekhi, Vill Dem. PO Deed, Ps Yachuli, Keyi Panor District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-BDO, CD Block Pistana, Keyi Panor District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2025 regarding total sanctioned order copy for all the beneficiaries of Dem Panchayat under MGNREGA.

2). The 1<sup>st</sup> hearing was held on 9<sup>th</sup> September' 2025. Shri John Diru, PIO-cum-BDO, CD Block Pistana, Keyi Panor District, Arunachal Pradesh and the Appellant Shri Nabam Pekhi were present.

3). The Commission had directed the PIO to furnish all the available information within fifteen days from the date of issue of the order. In case information were not available, justifiable reasons in writing had to be furnished through AFFIDAVIT. The Commission also had asked the Appellant to visit office of the PIO and collect the information.

4). The Appellant vide letter dated 24/09/2025 intimated his dissatisfaction for non furnishing of complete information by the Public Information Officer to the Commission.

5). Therefore, the Commission hereby decided to fix a date of hearing.

6). **The next date of hearing is fixed on 18<sup>th</sup> November'2025 (Tuesday) at 1100hrs.**

7). Therefore, Shri John Diru, PIO-cum-BDO, CD Block Pistana, Keyi Panor District, Arunachal Pradesh is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.

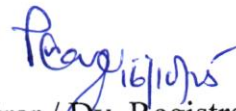
