The appellant filed an RTI application dated 17.12.2024 seeking following information regarding Departmental Recruitments of 100 Nos. junior Engineer Post, 100 Nos. of UDC post and other skilled and unskilled post of Drivers and MTS Approved and sanctioned in white file No. DPR-11/29/2022(Computer No. 87910) dated 16/10/2024.

## Details of the Information required-

- 1. CTC of advertisement publishes in the local newspaper.
- 2. CTC of appointment order issue to all selected candidates
- 3. CTC of list of all applicants and final list of selected candidates.
- 4. CTC of details of name and designation of the selection/Recruitment committee members
- 5. CTC of Minutes of meeting during the recruitment process
- 6. CTC of Administrative approval and financial approval documents for conducting the departmental recruitment process and creating/sanctioning of all the post
- 7. CTC of approved departmental recruitment Rules and guidelines for all the post
- 8. CTC of complete file noting shows sequence of approval including administrative and financial sanctions for all the post.

9. CTC of Govt. order or circulars authorizing Dept to recruit the all Post. 10. CTC of details of fund Allocated and utilized for Departmental Recruitment Purpose.

Period for which Information is sought for: 2022 to 2024

## Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that the FAA has heard the appeal and disposed off it as there was no solid ground to hold the case for further course of action.

The PIO is directed to furnish a satisfactory written reply on this point to the appellant, and through an affidavit to this commission within one week from the date of issue of this order. The appellant shall serve a copy of this order to the PIO, obtain acknowledgement and submit a copy to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant, this appeal case shall stand closed.
