Information sought:

The appellant filed an RTI application dated 17.10.2024 seeking following information regarding State Own Revenue (SOR) Performance Grant.

Details of information required:

1. Total funds allotted to 03 East Kameng.
2. Copy to notice inviting tender.
3. Details of Execution of works till today.
4. All the Records in connection with participants in tender process.

5. Details of payment made to the contractors.
6. Present status of work and fund position.
7. Completion certificate of works and photograph of executed work.

Period: 2022-23

The following were present.

Appellant : Present.
He states that the PIO has not furnished any information to him irrespective of direction given by the FAA.

Respondent PIO : Absent. Shri Achung Gyadi, Nodal Officer represented the PIO through VC. The representative of PIO states that the information is available with PIO (DPDO) and the appellant may collect it.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that the FAA – Deputy Commissioner, Seppa, has heard the first appeal and passed an order dated 03.03.2025 directed the PIO to furnish the information to the appellant within 2 weeks. The appellant is directed to serve a copy of this order to the PIO and collect the information documents from the PIO within two weeks from the date of issue of this order. The appellant shall file a written submission to this commission about the status of the information received.


Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO.
