An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-288/2025.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono for non-furnishing of below mentioned information by the PIO o/o the Executive Engineer (WRD), Seppa Division, East Kameng District, (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 20.01.2025.

A) Particular of information: Regarding the C/o Protection wall at Kochi Nallah Seppa.

B) Details of information required:

- 1. Copies of MOA/MOU/agreement made in between WRD Department and concern company/firm for the Implementation above mentioned project.
- 2. Copies of total sanction amount order letter along with additional sanction amount.
- 3. Copies of executed contractors/firms name.
- 4. Copies of acceptance letter awarded to the contractors/firms.
- 5. The copies of financial, technical & final bidding documents.
- 6. The copies of quantity of work executed till date.
- 7. The copies of U/C submitted by the department to the State government/central government.
- 8. The copies of monitoring report, money receipt and completed report.
- 9. The copies of name of the third party monitoring agency along with guidelines can for third party monitoring or implementation of the said project.
- 10. The copies of News paper cutting published in any local or national news papera agency as NIT with front page which were published by which news paper agency.
- 11. The copies of name and the place where the work executed / implemented.
- 12. The copies of details of GST payment or bills paid or in details.
- 13. The copies of completion certificate of the work.
- 14. The copies of works experience, documents of the Firms /contactors.
- 15. The copies of P/A holder and name of firm/company in details.
- 16. The copies of colour videos, audios and photos clips were taken (before, duringand after the work executed/completed.

- 17. The copies of GEO-TAGG (Before, during and after the work executed completed.
- 18. The copies of work order and total numbers of tender participated list & total list of selected Firms for awarded the project.
- 19. The copies of DIPR in details.
- 20. The copies of all letter pad/DO letters by Hon'ble Minister, MLAs for awarding of contract work.
- 21. The copies of NIT & NIQ submission letters.
- 22. The copies of cheque issued to contractor, firm, agency and company with cheque no. in details.
- 23. The copies of money paid to firm/contractors and balance amount.
- 24. The copies of MB & Copies of payment Bill/Payment of Boucher's.
- 25. The copies of present status of the project.
- 26. The copies of any union, association, organization and individual complaint against the project if so far.
- 27. The copies of EMD and copy of Bank Guarantee (BG)
- 28. The copies of Security money deposited by the firms/contractors.
- 29. The copies of Trading Licenses and profile details.
- 30. The copies of competitive charts/statement charts.
- 31. Period for which information required: inceptions to till today.

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Mamu Sono had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (WRD), Wester Zone, Govt. of A.P, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 24.02.2025.

Records further reveal that the FAA had conducted the hearing on 20..03.2025 wherein both the appellant and the PIO were present, the FAA, vide order dt. 21.03.2025, had directed the PIO to furnish the information as sought by the appellant within 30 days with liberty to the appellant to approach this Commission if he is not satisfied with the order passed by him

Hence, this appeal before this Commission which has been listed and heard today on 25.07.2025 wherein the appellant is absent without any intimation but the PIO, Er. Shri Gonong Pertin is present in person.

Heard the PIO who submits that he has brought in the requested documents to be furnished to the appellant. But the documents could not be provided to the appellant as he is not in attendance.

This Commission perused the documents/replies brought in by the PIO vis-à-vis the queries in the RTI application of the appellant which were found to be in order except few which needed further clarification. The PIO is advised to get the same clarified / elaborated and provide the same to the appellant who shall collect from the o/o the PIO.

The appellant shall collect the documents within one week from the receipt of this order and intimate the receipt thereof this Commission one week thereafter failing which this appeal shall stand closed.
