ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, RWD, Khonsa Division, District : Tirap, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 11.11.2024.

Particular of information: C/o "The total list of projects sanctioned under Pradhan Mantri Jan Karyakaram (PMJKV), erstwhile-MsDP Scheme, Ministry of Minority Affairs Govt. of India" during the financial year 2015-16.

This appeal is heard today on 11.07.2025 for the 2nd time, the 1st time being on 6th June, 2025. The appellant, Shri Tamchi Gungte and the APIO, Shri Rigi Geyi, Draughtsman-II, representing the PIO, were present on 06.06.2024. On that day this Commission, upon hearing the parties and on perusal of the documents brought in by the APIO, which were found not properly indexed, returned the documents to the APIO with advice to get properly indexed and signed by the PIO with seal. This Commission also directed the PIO, EE (RWD), Khonsa Division to collect the documents from the o/o the EE, Longding Division and furnish to the appellant. The EE(RWD), Longdin Division was also directed to provide the requested documents to the EE, Khonsa Division as mandated under sub-section(5) of section 5 of the RTI Act so as not to constrain this Commission to take avoidable penal action under the RTI Act.

Today, the PIO, Er. Shri W. Hondique, the EE (RWD), Khonsa Division and the appellant are present in person.

Heard the parties.

The PIO, in compliance with the Commission's direction, had brought in the requested documents/information and furnished to the appellant during the course of hearing. A copy of the letter dt.08.07.2025 forwarding the information to the appellant was also endorsed to this Commission.

This Commission, on perusal of the replies furnished by the PIO, found that the replies against most of the queries have been shown as 'NA' which the appellant as well as this Commission could not comprehend as to whether this abbreviation stands for 'Not Available' or 'Not Applicable'.

As such the PIO is directed to furnish the clarification and **with reasons** for the 'Not Available' or 'Not Applicable' whichever is the case.

The appellant is also directed to go through the documents/replies furnished against rest of the points and intimate to this Commission of further shortfall, if any, within one week from today for further consideration of the appeal.
