ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Kumar Tayam, Jami-Jatte, 6-Kilo, Po/PS Itanagar Papumpare District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Directorate of Printing & Stationary, Govt. of Arunachal Pradesh, Papu Nallah, Naharlagun, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 11/03/2025 regarding appointment of Director, Joint Director, Dy. Director, Assistant Director, Group-B & C.
- 2). The 1st hearing was held on 9th September' 2025. Shri B. Goswami, PIO-cum- Under Secretary, O/o Secretary Printing & Stationary, Govt. of Arunachal Pradesh, Civil Secretariat, Itanagar, and the Appellant Shri Kumar Tayam were present.
- 3). The PIO-cum- Under Secretary, O/o Secretary Printing & Stationary, Govt. of Arunachal Pradesh, Civil Secretariat, Itanagar, had informed that the information sought by the Appellant were related to the Directorate of Printing, therefore vide M/No. SIPR-RTI/2024 Dtd. Itanagar, the 18th March, 2025 the application of the Appellant was transferred to the Directorate of Printing, with direction to furnish information to the applicant. The PIO also had submitted a copy of the letter with Appellant's signature acknowledging receipt of the said letter.
- 4). The Commission, after hearing both the parties, had directed the Public Information Officer, Directorate of Printing & Stationary, Govt. of Arunachal Pradesh, Papu Nallah, Naharlagun, Arunachal Pradesh to furnish all the information as sought by the Appellant within 15 (fifteen) days from the date of issue of the order in consonance with the provisions of RTI Act 2005, with a caution that in case of failure to implement the directions of the Commission, the concerned PIO from the Directorate of Printing & Stationary would be summoned before the Commission's court.
- 5). The Appellant vide letter dated 19/09/2025 informed the Commission that the Public Information Officer, Directorate of Printing & Stationary, Govt. of Arunachal Pradesh, Papu Nallah, Naharlagun has not furnished information as directed by the Commission.
- 6). Therefore, the Commission hereby decided to fix a date of hearing.

- 7). The next date of hearing is fixed on 11th November'2025 (Tuesday) at 1100hrs.
- 8). Therefore, the Public Information Officer, Directorate of Printing & Stationary, Govt. of Arunachal Pradesh, Papu Nallah, Naharlagun, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.
- 9). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
