An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-580/2025.

APPELLANT : Shri Pisa Tapam, G-Extension Naharlagun.
RESPONDENT : The PIO, o/o the Executive Engineer (RWD), Block Hayuliang, Anjaw District.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (RWD), Block Hayuliang, Anjaw District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 07.03.2025.

Name of Scheme:

Details of Information:

1. Furnish details of sanction order copy from Govt., of India under VVP (Part-II) for the year 2023-2024 of above mentioned schemes.
2. Furnish details sanction order copy from your district concern department and: state government against VVP(Part-II) for the year 2023-2024 of above mentioned schemes.
3. Furnish the Details Project Report of above mentioned schemes.
4. Furnish the copy of notification and NIT under VVP (Part-II) of above mentioned schemes.
5. Furnish the total number of firm/contractor participated in the said tender process and class of firm /contractors and type of tender.
6. Furnish the copy of declaration of tender bids result and name of the successful bidder along with rate quoted by successful bidder and other non responsive evolution.
7. Furnish the name and designation of Tender Evolution Committee and copy of approval letter issued by the competent authority.
8. Furnish the copy of work order and acceptance letter for processed to work to the successful bidders/firm/contractors and comparative statement with department rate of all technical qualified firm, BOQ of qualified firms and agreement letter, process work order letter and mobilization release amount.

9. Furnish the copy of govt. guidelines under VVP (Part-II) order/notification and circular, if any for implementation of above mentioned work.
10. Furnish the duration and stipulated period of above said project.
11. Furnish the technical sanction order copy of above mentioned schemes.
12. Furnish the technical bid and financial bid documents.
13. Furnish site inspection report of each project starting to ending and monthly progress report.
14. Furnish the bill copy and money receipt copy if released.
15. Furnish the work executive EE/AE/JEs name of above mentioned schemes
16. Furnish Geo-tag & Photograph copy of each project from starting to ending.
17. Furnish the Utilization Certificate
18. Furnish the NOC copy of concern village i.e HGB, GBs of each project
19. Furnish the agreement copy with land owner should be made judicial stamp paper with seal and signature of judicial magistrate of above mentioned schemes
20. Furnish NOC from Forest, PHED & WS, WRD, RWD, Agri/Horti, PWD, Electrical etc. for non-duplicacy of the project.
21. Details if any furnished along with cheque counterfoil and payment made for land compensation to any person, if so indicate the name of beneficiary.
22. Furnish all the documents in CTC.
23. Furnish the LOC copy time to time released.

Period for which information is asked for: 2023-25

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Pisa Tapam had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to file his 1st appeal before the Chief Engineer (RWD), (PMGSY) Govt. of Arunachal Pradesh, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 29.04.2025. But having failed to obtain any response from the PIO or the FAA the appellant filed his 2nd appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.14.07.2025.

This appeal was heard on 17.09.2025 and 22.10.2025 and the following orders were passed:

a) 17.09.2025:

"This Commission, after hearing both the parties, then directed the PIO to submit in the next hearing a certificate from competent authority to the effect that the roads being constructed falls in sensitive locations from the security point of view and that the disclosure of information in respect of the projects mentioned in the RTI application of the appellant would prejudicially affect the security of the State and adjourns the hearing to 22.10.2025. The PIO, during the course of hearing, had assured that in case he fails to produce the aforesaid certificate in the next hearing, the requested documents shall be furnished to the appellant, which this Commission and the appellant had agreed to."

On 16.01.2026, both the appellant and the PIO were absent but the PIO informed vide his letter dt13.01.2026 that he was pre-occupied with a meeting called by the Secretary (RWD) SE at Namsai.

This Commission perused the complaint of the appellant as above and concluded that if the replies / documents in respect of the points at serial numbers mentioned in the letter as above, were infact, not furnished as complained, then it amounted to violation of the provisions of the RTI Act 2005.

This Commission, reminding the PIO of the requirement of law to furnish the requested information to the appellant, which are not exempted under any of the exemption provisions prescribed by RTI Act, however, made clear that if the information/documents are not held by the o/o the PIO, then he shall declare so by way of an affidavit clearly mentioning the reason therefor in terms of section -7(8)(i) read with section-18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

The PIO was, thus, directed to comply with the direction as above and report compliance thereof on 13.02.2026.

Today on 13.02.2026 the APIO, Er. Shri Sangio, J.E is present but the appellant is absent for the second consecutive time.

Heard the APIO who submitted that the appellant has already been furnished the requested documents/information and therefore, incomplete furnishing of the requested documents as claimed by the appellant does not arise.

This Commission upon hearing the APIO and considering the fact that the appellant did not attend the hearing for 2(wo) consecutive times, concludes that the appellant is no longer interested in adjudication of his appeal by this Commission. Resultantly, this Commission decides to close this appeal which it does accordingly.

b) 22.10.2025:

"Today on 22.10.2025, the appellant, Shri Pisa Tapam is present through VC while the PIO, Er. Shri Tame Tach, EE is present with the requested documents/information who submitted that he could not obtain the certificate exempting the disclosure of documents in respect of the projects undertaken in border areas under section 8(1)(a) of the RTI Act and therefore, he has brought in the documents as assured.

Since the appellant is not present physically, the documents have been retained in the custody of the Commission which the appellant shall collect within 3(three) weeks from today and intimate his satisfaction or otherwise therewith on 16.01.2026 the next date of hearing which has been fixed on the request of the PIO."

In compliance with the order dt.22.10.2025, the appellant collected the documents from the office of this Commission and vide his letter dt.23.10.2025, complained as under:
