**An Appeal Case U/S 19(3) of RTI Act, 2005**

**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD), Sangram Division, Kurung Kumey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.02.2025.

**A. Particulars of the Information:** Under Budget Estimate (BE) 2023-2024.

1. Augmentation and Retrofitting of old existing "DC Office at Koloriang Kurung Kumey District (Phase-I).
2. C/o Residential Building 2nos of type-II & 2nos. Type-III for staff of District Administration at Sarli CO Har. Kurung Kumey District.
3. C/o Pla Ground with RCC Gallery VKV School Koloriang Kurung Kumey Dist.
4. C/o T 1e-II Teacher Qtr. 2nos. with CC Wall upto window level and Dyna sheet roofing with steal trust for Govt. Middle School Taba under Damin circle Kurung Kumey District (A.P)
5. C/o School Building Govt. Middle School Koloriang Bhaluklong

**A. Details of Information required**

- i) Work order by particular name/firm.
- ii) MB Note
- iii) DPR
- iv) Cheque counter foil particular by name;
- v) LOC
- vi) 3 times geo tagged photo
- vii) Payment details
- viii) Details of credit amount
- ix) Details of account number in which amount credited
- x) Bank & Branch Name which amount credited from concerned department
- xi) Completion Certificate.

**Period for which information asked for: 2023-2024**

**Brief facts emerging from the appeal:**

Records emerging from the appeal disclose that the appellant, Shri Bamang Pacho had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer, (PWD), Central Zone-A, Itanagar, Govt. of A.P, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 04.04.2025 .

Records further reveal that the First Appellate Authority-cum-Chief Engineer, Central Zone-A, PWD, AP, Itanagar conducted a hearing on 25th April, 2025 wherein the appellant Shri Bamang Pacho was present but the Respondent PIO was absent. The FAA, vide order dt.29.04.2025 then passed the following order:

*"After hearing the case, it was found that the PIO has failed to reply/furnish the information as sought by the appellant in his RTI Form A received dated 22.02.2025 via post within the stipulated time period.*

*Therefore, the respondent PIO was directed to furnish all documents except information sought at Sl. No. iv i.e Cheque counter foil particularly by name, Sl. No. ix i.e Details of account number in which amount credited and Sl. No. x i.e Bank & Branch Name which amount credited from concerned department. Instead, the payment amount in writing should be provided to the appellant. The Respondent PIO was directed to furnish the information by 25<sup>th</sup> May, 2025 without fail."*

However, the appellant having failed yet again to obtain the information preferred 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 05.05.2025.

**Hearing and decision:**

This appeal is, accordingly, heard today on 08.10.2025 wherein the appellant, Shri Shri Bamang Pacho is present in person but the PIO is absent who, however, informed vide his letter dt.06.10.2025 that he will not be able to attend the hearing scheduled due to his pre-occupation in handing and taking over charges of newly bifurcated Koloriang Division, PWD, AP, Koloriang and requested for adjournment of the hearing.

In this regard he has also enclosed the copy of order from the Superintending Engineer which is extracted below:

**" OFFICE ORDER**

*Consequent upon creation of PWD Division at Koloriang vide Govt. Order No. PWD-11022/2/2022-Estt-PWD/231-40 dated 23<sup>rd</sup> June, 2025 and subsequent joining of Shri Yomken Karga as Executive Engineer, Koloriang Division, PWD, AP, on 23/09/2025 (A/N), the Executive Engineer, Sangram Division, PWD, AP, Sangram is hereby directed to handover following PWD Sub Division with men & materials to the Executive Engineer, Koloriang Division, PWD, AP, Koloriang with immediate effect.*

1. Koloriang PWD Sub-Division
2. Patuk PWD Sub-Division
3. Damin PWD Sub-Division.

*A proper handing and taking over of projects / schemes, man power, projects / Schemes related files and documents, audit paras, court cases, RTI cases, pending liabilities etc. pertaining to aforementioned PWD Sub-Division, should be made. Project /scheme if any is under tendering process, may be handed over separately on completion of tender process.*

*Copy of the handing / taking over note must be submitted to this office as well as Zonal office for record.*
