## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of Rural Work, Longding Division, District Longding, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Konsa.
- 2). The 1<sup>st</sup> hearing was held on 2<sup>nd</sup> September' 2025. Shri R.W. Zimik, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh, PIN-792131 and the Appellant Shri Wangnon Wangnow were present.
- 3). The Commission had asked the Appellant to visit the office of the PIO to sort out the issues and get the complete relevant information for Sl.no. 2, 4 & 11 from the PIO. The Commission also had directed the PIO to furnish complete information to the Appellant within fifteen days from the date of issue of the order.
- 4). The Appellant vide letter dated 19/09/2025 informed the Commission that the Public Information Officer has not furnished information as directed by the Commission.
- 5). Therefore, the Commission hereby decided to fix a date of hearing.
- 6). The next date of hearing is fixed on 11th November'2025 (Tuesday) at 1100hrs.

- 7). Therefore, Shri R.W. Zimik, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.
- 8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
