Information sought:

The appellant filed an RTI application dated 20.11.2024 seeking following Information regarding payment of compensation to the land affected persons of 132 KV Transmission line from Naharlagun to Sagalee.

Details of Information required:

- Furnish the total sanction amount for land compensation.
- Furnish the total number of beneficiaries clearly sowing the amount paid to them.

- c. Furnish the cheque counterfoil being the payment made to the land affected person.
- d. Furnish the DPR cops of the project.
- e. Furnish all the survey report along with Gea tag with aerial Measurement.
- f. Furnish the total area of land affected by the project.
- g. Furnish the rate of the compensation for various items i.e. land, timber, plantation, bamboo, horticulture garden, pineapple, orange, Banana Garden etc.

Relevant facts emerged during hearing:

Previous Hearings:

First Hearing : 10.04.2025

In first hearing ordered as: *"The Commission has ordered that: (a) The PIO shall transfer a copy of RTI application in form-A of the appellant to the PGCIL, Nirjuli for the information sought under serial no. (d) Under intimation to the appellant. The appellant shall approach to the PGCIL. (b) The appellant shall file a written submission to the PIO clearly specifying the short fall in the information already furnished to him within one week from the date of issue of this order. On receipt of such written submission the PIO shall furnish the additional information within the context of original RTI application within three weeks from the date of issue of this order i.e on or before 01.05.2025".*

The following were present.

Appellant : Present. He states that he is aware that information pertaining to PGCIL has been transferred to PGCIL by the PIO. Information pertaining to PIO at serial (b) in RTI application is yet to receive from the PIO.

Respondent PIO : Absent. Shri Sanjib Pegu (LDC) represented the PIO. The representative of PIO has stated that the RTI application has been transferred to Power Grid for information sought in point no. (a). The information pertaining to serial no. (b) in RTI application was brought to the commission court today to hand over to the appellant. Accordingly, appellant received the information document.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that the PIO has furnished all the information available with him. The appellant is directed to examine and verify the adequacy of information provided by the PIO within one week and submit a written report to this commission **on or before 21.07.2025**. In case, no

compliance report is received and any further grievance from the appellant it will be presumed that the appellant has already received the satisfactory information or no more interested for his appeal case, then this appeal case shall be disposed of and closed without further hearing.

Hearing adjourned. Next date of hearing shall be fixed after receipt of compliance report of this order from PIO and Appellant.


