**ORDER**

The Appellant, Shri Bamang Pacho had filed 4(four) appeals under section 19(3) of the RTI Act for non-furnishing of information he had sought from the PIO vide his RTI applications as mentioned below by the PIO, o/o the E.E (PWD), Sangram Division, Kurung Kumey District:

These appeals were registered and heard in this Commission on different dates viz, APIC-366/25 dt. 07.11.2025, APIC-367/25 dt. 21.11.2025, APIC-368/25 dt.08.10.2025 and APIC-369/25 dt. 28.11.2025.

This Commission, after hearing the PIO, o/o the EE (PWD), Sangram Division and upon perusal of the Govt. order produced by the PIO, noticed that on creation of Koloriang (PWD) Sub-Division, the subject/documents related to Koloriang Division as requested in the aforesaid appeals/applications, had been handed over to the Koloriang Division by Sangram Division on 14.10.2025.

In view of the bifurcation of the Koloriang Division and handing over of the documents related to Koloriang jurisdiction to Koloriang Division, this Commission summoned both the PIOs of Sangram and Koloriang Divisions to hear them and decide as to whose Division shall provide the requested documents to the Appellant.

Accordingly, today on 21.01.2026 Er. Shri Yomken Karga, E.E (PWD), Koloriang Division and Shri Bini Tare, in-charge RTI Cell o/o the E.E, PWD, Sangram Division are present.

Since the appeals are against the same PIO and pertain to the same particulars i.e Budget Estimate-2023-2024, the appeals have been clubbed together and heard accordingly.

Heard the parties.

The PIO, Koloriang Division submitted that the information/documents requested by the Appellant have to be sorted out and collated from the records received from the Sangram PWD Division for which his office would need sufficient time.

The representative of the PIO, Sangram (PWD) Division, Shri Bini Tare assured that any documents /information, remained, if any, in the o/o the PWD, Sangram Division, shall be provided to the PIO, Koloriang PWD Division for onward furnishing to the Appellant.

In the premises as above, this Commission, by this common order, directs the PIO, o/o the E.E (PWD), Koloriang Division to furnish the information/documents requested by the Appellant in his above four applications within a period of 3 (three) months and in any case, not later than 30<sup>th</sup> April, 2026.

Thereafter, the Appellant shall intimate this Commission of the receipt of the information within 1 (one) week of the receipt of the same from the PIO for further consideration of the appeals.
