**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Enam Yangfo, Bazarline Seppa, PO/PS Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DPDO, Govt. of A.P., O/O the District Panchayat Development Officer, Old DC Administrative Building Seppa, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/09/2024 regarding transferred / Distribution of Performance Grants (SoR) funds of Rs. 8, 48, 70, 000 of 2022-23 under XV FC in GPs & ZPs Accounts.
- 2). The 3<sup>rd</sup> hearing was held on 8<sup>th</sup> July' 2025. The PIO-cum-DPDO, Govt. of A.P., O/O the District Panchayat Development Officer, Old DC Administrative Building Seppa, East Kameng District, Arunachal Pradesh was represented by Shri Achung Gyadi, APIO, while the Appellant Adv. Enam Yangfo had appeared before the court through video conferencing.
- 3). The Commission had then directed the APIO to furnish information directly by hand, and asked the Appellant to collect the information from the office of the PIO and intimate his satisfaction or dissatisfaction.
- 4). The Appellant vide letter No. nil dated 03/08/2025 informed the Commission that after receiving the sought information from office of the DPDO Seppa and upon careful perusal, he admitted to having made error in his application to the PIO. However, appealed the Commission to dispose of the present case [APIC-118/2025 (Appeal)] with permission to file a fresh RTI application on the same subject matter with necessary corrections and modifications.

4). The Commission in view of the appeal, hereby dispose of the case with permission to apply a fresh application for any additional information on the same subject but with a condition that no repeat information would be furnished.

5). Therefore, the case is hereby disposed of.
