ITANAGAR. An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-62/2025.

APPELLANT

: Shri Riya Taram & 2 others, Huto colony Jollang.

RESPONDENT

<u>ORDER</u>

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar and Shri Lokam Namdu for non-furnishing of below mentioned information by the PIO, o/o the Divisional Forest Officer, Distt. Lohit, Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 09.10.2024.

A) Particular of information: To furnish all the relevant information against the released fund amounting to Rs. 1106.13636 Lakhs of LOC for the month of March, 2024 to DFO account for proper implement of the items under CA, WLM & NPV components of the State CAMPA AOP Voi I & II during 2023 – 2024 under department of Environment & Forest & Climate change as per sanction order.

B) Details of information required:

- 1. Technical Sanction Order/DPR/Estimate/ UC;
- 2. Name of work list with Geo-tag;
- 3. List of all the work order/supply order copy with details of payment like cheque book counter foil/leaf/demand draft/banker cheque/deposit challan and PFMS Transaction details as according to the amount mentioned in work order sanction order/First & final copy / MB Name of Firms who won the tender work with respect to the subject mentioned above;
- 4. Description of work/supply work/quantity/rate/per nos./amount with cash memo/money receipt of every materials;
- 5. Photo copy of all the firms/trading license of Contractors / Enterprise with its Bank account number/cheque book counterfoil/leaf/challan of deposited amount against GST/ Royalty to Govt. account by DFO/RFO/Firms/Enterprise;
- 6. NOC copy of Head Gaon Bura/Gaon Bura and Gaon Buris from concern villages;
- 7. Copy of legal agreement between contractor/land owner and department for carry out work through Magistrate counter sign and HGB/GB countersign with seal;
- 8. Name of contractor or what Firm /Enterprise owner and proprietor is to RFO/DFO or what connection to them;
- 9. Total area square of land with longitude and latitude of area/exact location of work area with LPC copy;

- 10. Money receipt/cash memo / challan of all the items/works/contractors/firms/cash book statement;
- 11. Details of payment list with money receipt of all the contractors/firms/Enterprise;
- 12. Bank account statement of DFO or Bank Account Statement of RFO with its account number;
- 13. Name of officers and officials who executed/handled the aforesaid work/prepared DPR/first and final bill and made payment. Give the name of officers who is holding the DDO power with the signature and seal;
- 14. Govt. notification /cabinet passed order copy for RFO to prepare DPR/Estimate/First and Final Bill of works/made payment without Engineer;
- 15. Details of fund/amount transaction to RFO account from DFO account;
- 16. Measurement Book (MB) with page number // hand receipt and payees name;
- 17. Various deduction of amount as percent from contractor bill payment by RFO/DFO;
- 18. Certified copy of all works by concern officer;
- 19. Description /photocopy of work site location before start of work/starting of work / ending of work site;
- 20. Billing detail sheet copy in particular RFO wise;
- 21. Scheme detail sheet particular Range Forest Officer and
- 22. NIT copy / date of NIT tender floated or conducted / total number of bidders /total apply of firms/name selected firm & contractors/press letter paper cutting/awarded firm details with cheque book counterfoil/leaf/demand draft/banker cheque/deposited challan and PFMS transaction details as according to the amount mentioned in work order/sanction order with account number of firm/contractor.

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Chief Conservator of Forest (CCF), Eastern Arunachal Circle, Tezu, Govt. of Arunachal Pradesh the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 18.11.2024. However, the appellant failed yet again to obtain the information and therefore, they preferred 2nd appeal before this Commission under section 19(3) of the RTI Act. 2005 vide their Memo of Appeal dt. 13.01.2025.

This appeal was earlier listed on 07.05.2025 wherein the appellant was present but the PIO was absent therefore, the hearing of this appeal was adjourned to toady 23.05.2025.

Today the appellant is absent but the PIO attended through VC who informed that the requested information has already been dispatched to the appellant on 22.05.2025 through the Speed Post, the tracking of which has been forwarded to this Commission vide WhatsApp which and s been taken on record.

The appellant is directed to intimate this Commission of the receipt of the documents and his satisfaction therewith within 2(two) weeks from today to enable this Commission for further order.
