Information sought:

The appellant filed an RTI application dated 16.06.2025 seeking following information regarding to furnish all the following relevant information against

1. Arunachal Frontier Highway viz LADA to Sarli.
2. Sarli to Huri.
3. Huri to Taliha in the District along with all Project affected families (PAFS) and realistic

Land

Furnish the following documents:

- 1) Furnish the sanction order copy for land compensation of village wise.

- 2) Furnish the Land compensation assessment copy of village wise.
- 3) Furnish the Land acquisition notification copy.
- 4) Furnish the claim & objection of land acquisition & compensation notification copy.
- 5) Furnish the selected list of affected land owners in village wise with their contact number.
- 6) Furnish the order copy & financial resolution of meeting with meeting attendance list.
- 7) Furnish the technical sanction (TS) copy of the entire above mentioned project.
- 8) Furnish the first & final bill copy of all the materials/areas of land.
- 9) Furnish the money receipt/payment list of affected land owner with their Aadhar card/PRC/ST/contact number.
- 10) Furnish the payment method like Xerox copy of the Cheque leaf/pay in slip for NEFT/RTGS/PFMS.
- 11) Furnish the MB (Measurement book) of all the affected families of land owners.

Period of information required: 2023 to 2025.

The following were present.

Appellant : Present. He stated that he has not received any information from the PIO. And FAA has also not heard the Case.

Respondent PIO : Absent.

F A A : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, hearing the appellant, observes that FAA – Deputy Commissioner, Koloring, Kurung Kumey District AP., has not disposed of the first appeal filed to him by following statutory procedure laid down in the Arunachal Pradesh Information Commission (Appeal Procedure) Rules, 2005. So, this appeal case is decided and determined in the absence of the PIO and FAA as has been made known to them in the hearing notice.

As laid down at para-38 of the Guidelines for the FAA issued by the GoI and the State Govt. OM No. AR-111/2008 Dated 21st August, 2008, adjudication on the appeals under RTI Act is a quasi-judicial function. It is, therefore, necessary that the Appellate Authority should see to it that the justice is not only done but it should also appear to have been done. In order to do so, the order passed by the appellate authority should be a speaking order giving justification for the decision arrived at.

Therefore, the instant appeal case is remanded to First Appellate Authority. Therefore, the **FAA –Deputy Commissioner, Koloring, Kurung Kumey District AP.**, following the principle of natural justice, shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within two weeks from the date of receipt of this order i.e. on or before **14.11.2025**.

The appellant is at liberty to file 2nd appeal afresh:

1. If the Appellant is not satisfied with the information furnished to him by PIO based on the judgement order passed by the FAA.
2. If the FAA has denied the requested information based on specific exemptions/ grounds provided under the RTI Act, 2005.

Fee for such 2nd appeal, if done, shall be exempted.
