ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD), Laaying Yangte Division, Kurung Kumey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.05.2025:

A. Particulars of the Information: Under Budget Estimate (BE) 2024-2025.

1. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type II Qtrs. (G+1) at GMS Koloriang.
2. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type II Qtrs. (G+1) at IGSS Nikja.
3. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type II Qtrs. (G+1) at GUPS Pachangriang.
4. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type - II Qtrs. (G+1) at GUPS Yarba.
5. Infrastructure Development of GSS Parsi Parlo (Kurung Kumey)

C. Period for which information asked for : 2024-2025

Brief facts emerging from the appeal :

Records emerging from the appeal disclosed that the appellant, Shri Bamang Pacho had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer, (RWD), Govt. of A.P (Western Zone), Itanagar the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 25.06.2025.

This appeal was, accordingly, listed on 19.12.2025, 21.01.26 an 13.02.26.

On 19.12.25, wherein the appellant, Shri Bamang Pacho was present in person but the PIO was absent without any intimation, this Commission, after hearing the appellant and perusing the points on which the appellant has sought the information/documents which were found not covered by the exemption provisions of section 8 of the RTI Act, 2005 and also taking note of the order passed by the FAA, directed the PIO to furnish the requested information and report the compliance thereof on 21.01.2026, the next date of hearing.

On 21.01.2026, the appellant, Shri Bamang Pacho was present in person while the PIO was represented by Er. Shri Yangbia Loka, AE /APIO.

The APIO then submitted that the documents pertaining to this appeal were with the Koloriang Division as the particulars of schemes mentioned in the RTI application of the appellant comes under the jurisdiction of PIO, o/o the RWD, Koloriang Division of Kurung Kumey District, (A.P). However, the APIO could not furnish any evidence / official records of the handing and taking over of the charges. He, however, vide his letter dt.19.01.2026 (extracted below) has requested this Commission to transfer the appeal in question to the PIO, o/o the EE, Koloriang Division.

In the premises as above, this Commission decided to hear the PIOs of both the Laaying Yangte and the Koloriang Divisions so as to finalise as to whose office shall furnish the requested information/documents to the appellant and accordingly, the PIO, o/o the E.E(RWD), Laying Yangte Division and the PIO o/o the E.E (RWD), Koloriang Division Koloriang Division were directed to be present in the next hearing fixed on 13th February, 2025 (Fri Day) with records / evidence of handing over and taking over of the charges of records/documents pertaining to schemes falling under the jurisdiction Koloriang Division.

As directed, Er. Shri Nani Tapa, the PIO, o/o E.E(RWD), Laying Yangte Division and Er. Shri Chera Teja, ASW, the APIO o/o the E.E (RWD), Koloriang Division Koloriang Division (the documents/information) appeared in person today on 13.02.20026. The appellant, Shri Bamang Pacho is also present in person.

The documents brought in by the PIO, Koloriang Division were perused by the appellant and this Commission as well and found that the documents were not properly indexed and certified. As such, the documents have been returned to the PIO with direction to refurnish the same duly certifies and indexed as per the queries of the appellant.

The PIO shall furnish the revised information/documents to the appellant within 2(two) weeks from the date of receipt of this order and the appellant shall, within 1(one) week, thereafter intimate this Commission of the receipt of the same failing which this appeal shall stand closed.
