**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa PO/PS Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Pake Kessang Division, Pakke Kessang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 29/05/2025 regarding Work Charge (W/C) serving under the Pakke Kessang Division & Sub-Divisions.
- 2). The 1<sup>st</sup> hearing was held on 25<sup>th</sup> November' 2025. Shri Mibom Tayeng, PIO-cum-EE (PWD), Pake Kessang Division, Pakke Kessang District, Arunachal Pradesh and the Appellant Shri Ashok Sangbia were present.
- 3). The Commission, had directed the PIO to give the total strength of the W/C under his division for a particular year / period. Under section 6(3) of the RTI Act the information which were beyond jurisdiction of the PIO-cum-EE (PWD), Pake Kessang Division, the PIO was directed to forward the RTI Application to the SE (Coord) for further furnishing of information to the Appellant. The PIO was also directed to intimate the same to the Appellant and the Commission within fourteen days from the date of issue of the order dated 25<sup>th</sup> November'2025.
- 4). The Commission had asked the Appellant to approach the PIO under SE (Coord) and collect information. After receipt of information the Appellant was directed to intimate his satisfaction or dissatisfaction.
- 5). The Appellant vide letter dated 27<sup>th</sup> December'2025 submitted that the PIO failed to furnish information as directed by the Commission and appealed the Commission for continuation of hearing.

6). The Commission to hear from the both the parties decided to fix a date of hearing.

7). **The next date of hearing is fixed on 3<sup>rd</sup> March'2026 (Tuesday) at 1100hrs.**

**8).Therefore,** the PIO-cum-EE (PWD), Pake Kessang Division, Pakke Kessang District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

9). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked against the PIO. In case the Appellant remains absent the case would be disposed of.
