An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-596/2025

Shri Taku Yekar -V/S- PIO-Cum-EE, PWD, Daporijo, U/subansiri District A.P.

ORDER

The 2nd hearing held on **16th October' 2025'** related to the **APIC No. 596/A/2025.**
Both the Appellant and the PIO are present during the hearing before the Commission.

Heard the Appellant;

The Appellant stated before the Commission that as per his Form-A application the PIO has provided to him the copies of 2 (two) covering letters that he has sought for, but his main intention was to obtain the copies of the details of bill prepared as well as the report submitted to the DRE bill amounting to Rs. 77,069,55.14/-.

Heard the PIO;

The PIO submitted that he has exactly provided what the Appellant has sought from him in his Form-A.

Had the Appellant sought for the details of the bill prepared and details of the report submitted to the DRE, he could have provided it to him while providing him the two covering letters.

After hearing both the parties the Commission hereby observes;

- i) The Appellant actually want the copies of the details of the bill prepared for amounting to Rs. 77,069,55.14/- and furnished to the DRE in form of a report. He want the details of the bill as well as the report regarding the information for which he has sought in the Form-A under Serial Nos. A and B which have already been furnished to the Appellant by the PIO.
- ii) After hearing the Appellant, the Commission observes that the intended information was the copies of the bill prepared and report submitted to DRE.
- iii) The PIO has furnished the information as sought, as per the Form-A application, so no fault lies with the PIO.
- iv) And therefore, the Form-A of the Appellant is amended and request for furnishing the copies of the bill as well as the report submitted to the DRE is included in the Form-A of the Appellant.

Under the above stated circumstances and facts the Commission hereby orders;

- a) The PIO to furnish the copies of the bill prepared in detail and the report submitted to the DRE, to the Appellant on or before the next date of hearing.
- b) The Appellant to intimate the receipt of the copies of the bill/report submitted to the DRE on or before the next date of hearing.
- c) The PIO to be present on the next date of hearing to ascertain the furnishing of the information(s) particularly the copies of the bill/report submitted to DRE on the next date of hearing without fail, failing which necessary action will be initiated as per the provisions of RTI, Act 2005 against the PIO.
- d) The Appellant to be present in the next date of hearing to intimate the Commission the receipt of the above amended information(s) sought from the PIO.
- e) Notice need not be issued to both the parties for the next of hearing as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 24 February' 2026' at 1:30 PM (Evening).
