**An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-299/2025.**

APPELLANT : Shri Mamu Sono, Sood Village, Naharlagun.

RESPONDENT : The PIO, o/o the Executive Engineer (WRD),

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, WRD, Seppa Division, East Kameng District, (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 20.01.2025.

A) Particular of information :- Regarding the SIDF, RIDF and SADA schemes since 2019-2024

B) Details of information required:

- 1) Furnish the copies of total sanction amount order letter.
- 2) Furnish the copies of total list of above mentioned schemes with name and locations and places where the works were executed/implemented.
- 3) Furnish the copies of BE and RE of all the above mentioned schemes.
- 4) Furnish all the seeking information documents in separately as per the schemes mentioned above names.
- 5) Period for which information required : 2019 to 2014

Brief facts emerging from the appeal and decision:

Records emerging from the appeal disclose that the Appellant, Shri Mamu Sono had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (WRD), W/Z, Govt. of A.P, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 24-02-2025.

The records further reveal that the First Appellate Authority conducted a hearing on 20.03.2025 and by order dt. 21st March, 2025 directed the PIO to furnish the required information as sought by the appellant within 30 (thirty) days from the date of issue of this order without fail which are furnishable as per RTI Act. 2005.

However, the appellant, apparently, failed yet again to obtain the information and therefore, preferred second appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide memo of appeal dated 28.03.2025

This appeal is, accordingly, listed and heard today on 08th August, 2025, wherein the appellant is present and the PIO, Er. Shri Gonong Pertin is also present with the RTI replies contained in the letter dt.06.08.2025. This Commission, on perusal of the said replies found that the replies have been mentioned as 'Not available' against all the queries which the appellant objected to as not satisfactory replies.

This Commission also holds that the replies, 'Not available' can not be accepted without any justifiable reason. As such, the PIO has been directed to furnish the specific replies to the queries i.e scheme-wise sanction order with the names of schemes and the locations within 2(two) weeks from today and the appellant shall, thereafter, within one week, intimate this Commission of the receipt of the same for further consideration of the appeal.
