**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the PIO –cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.
- 2). The 18<sup>th</sup> hearing was held on 3<sup>rd</sup> June, 2025. Representative of Shri Kocho Jomoh, the PIO –cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh Shri Taba Guch, APIO-cum-B.E.O had furnished remaining information after the hearing.
- 3). The Appellant vide letter no. nil dated 04/06/2025 informed the commission that the PIO had not furnished information for sl.no. 2, 3, 5, 6, 7, 11, 12, 14, 16, 21, & 22 of the Form-A dated 07/03/2022
- 4). The Commission, decided to fix next date of hearing to ensure compliance by the PIO and also provide an opportunity to the PIO to respond to the Appellant.
- 5). The next date of hearing is fixed on 22<sup>nd</sup> July, 2025 (Tuesday) at 1100hrs.

6). Therefore, Shri Kocho Jomoh, the PIO –cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court on the scheduled date and time without fail. Take notice that in case of default in appearance on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
