**An Appeal Case U/S 19(3) of RTI Act, 2005**

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono for non-furnishing of 30 (Thirty) point information on c/o protection wall and head work at Rabjeewa Agricultural field at Seppa, East Kameng by the PIO, o/o the Executive Engineer (WRD), Seppa Division, East Kameng District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 20.01.2025.

**Brief facts emerging from the appeal and decision:**

Records emerging from the appeal disclose that the Appellant, Shri Mamu Sono had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (WRD), W/Z, Govt. of A.P, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 24-02-2025.

The records further reveal that the First Appellate Authority conducted a hearing on 20.03.2025 and vide order dt. 21st March, 2025 directed the PIO to furnish the required information as sought by the appellant within 30 (thirty) days from the date of issue of this order without fail which are furnishable as per RTI Act. 2005.

However, the appellant having failed yet again to obtain the information preferred second appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide memo of appeal dated 28.03.2025.

This appeal is, accordingly, listed and heard today on 08<sup>th</sup> August, 2025, wherein the appellant, Shri Mamu Sono is present in person. The PIO, Er. Shri Shri Gonong Pertin, EE is also present with the requested documents which has been handed over to the Appellant who has been directed to go through the same and report his satisfaction or other wise therewith within one week from today for further consideration of the appeal.
