### **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 26(twenty six) point information Construction of 100 bedded Girls Hostel at Govt. Secondary School, Monigong and Construction of 50 bedded Girls Hostel at Govt. Secondary School, Tato in Mechuka Block in Shi Yomi District during the financial year of 2023-24 by the PIO, o/o the Executive Engineer (PWD), Mechuka Division as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.10.2024.

This appeal was heard on 04.07.2025 wherein the PIO, Er. Shri Onit Borang, E.E was present in person but the appellant, Shri Tamchi Gungte did not appear but informed vide letter dt.04.07.2025 that due to some serious health issues he will not be able to attend the hearing.

The PIO submitted that he had no knowledge of this particular appeal and therefore, he will not be able to make any submission in this appeal and hence requested for a copy of the RTI application filed by the appellant. As requested, a copy of the RTI application dt. 11.11.2024 filed by the appellant before the PIO was provided to the PIO and adjourned the hearing of this appeal to today on 08.08.2025 with direction to provide the requested documents to the appellant as per his RTI application and report compliance on or before 08.08.2025.

Today the appellant was present in person. The PIO was also present with the requested documents/information which has been handed over to the appellant who has been directed to go through the same and report his satisfaction or otherwise therewith to this Commission within 2(two) weeks for further consideration of the appeal.
