**Information sought:**

The appellant filed an RTI application dated 26.11.2024 seeking following Information against the Name of Work/Scheme which copy enclosed with form, A under SIDF. 2022-2023 for Realignment & Reconductoring of outlived HT/LT Lines under Deomali Electrical Sub-division Tirap District at Amount of Rs. 180.00 was awarded to M/s. W.L Enterprise LOAM = 180.00 out of Rs.200.00. And also Give Reason for why EE/AE/JE Has taken Deduction of amount from Sanction amount/Estimate Cost (Rs.) Contractor as Percentage i.e. 21% GST/IT, 10% EE, 5% AE, 4%JE as per copy from Reliable sources is Enclosed herewith form, A.

**Details of information Required: -**

1. Furnish the (TS) Sanctioned order/DPR/Estimate/UC/LOC.
2. Give the Work order/Supply order copy.
3. Give the Name of Contractor/firm/enterprise with their Bank account number.
4. Furnish the First & final Bill copy of all the works which must be prepared as per the amount which mentioned in the Sanctioned order/workorder/Loc/Loa.
5. Give the Scheme detail sheet copy/Billing details sheet copy of all the works.
6. Give the Measurement Book (MB) details and cashbook Statement of works. it must be maintained as per the Sanction amount which mention in the Sanction Order/LOC/Work order/Supply order copy/Hand Receipt and Payees Name with its Signature
7. Give Xerox the copy of Cheque Leaf/Cheque counterfoil/bill payment, counterfoil/demand, draft/banker bookcheque/RTGS/PFMS Transaction against the above-mentioned M/s. W.L enterprise and full name of W.L Enterprise. It should be paid as according to the Sanction amount which mentioned in the Sanctioned order(TS) LOC/Work order/loa.
8. Give the description of work/Supply work/Quantity/rate/per nos/amount with cash memo/money receipt of every material.
9. Give the Xerox copy of M/s. W.L Enterprise Trading License with their Bank account number. what is the NEXUS between Proprietor of M/s. W.L Enterprise and AE/JE/EE? Give the full Name of EE/AE/JE and Trading License owner/Proprietor of M/s. W.L enterprise.
10. Give the Money deposited challan of Govt. Account against GST/Royalty by above mention Enterprise/EE Deomali Electrical account.
11. Give the list of Money Receipt/Payment List of all the Contractor with their Full Name and address/Contact Number/Cashbook Statement of works.
12. Give the Hard copy of above-mentioned enclosed copy herewith form A which is regarding the List of Scheme under Deomali Sub-division 2022-23. Deomali Section.
13. Give the Name of Officers and Officials/Field officers with Designation who Is/was the DDO Power or Executed the Above-mentioned work/Fund.
14. Explain the detail Reason. why EE/AE/JE Has taken amount from Sanction amount/Estimated Cost (Rs) & Contractor Payment as Percentage i.e. 21% GST/IT,



- 10% for EE, 5% for AE, 4% for JE against the above mention work or Who injunction them to do such activities?
15. Why only amount of Rs. 180.00 has been awarded to M/s. W.L Enterprise for Realignment & Reconductoring of outlived HT/LT Lines under Deomali Electrical Sub-division Tirap District at out of Rs. 200.00. Explain the Reason.
  16. Give the Certified colouring Photocopy of all works by concern PIO.
  17. Furnish the description Colouring Photocopy of work site before starting of work/Starting of work and ending of work site/Colouring photocopy of Geo-tag report.
  18. Furnish the Billing details Sheet copy/Scheme details Sheet copy of above mention works.
  19. Give the NIT Copy/Date of NIT Tender floated or Conducted/Total number bidders apply of firms/Press Letter Paper Cutting/Photography/Videography of Tender Committees during the Tender called time/List of Tender Committee.
  20. Give the tender agreement/Justified copy/Approval/Acceptance/EMD/Bank guarantee/MIS Report/UC Sign by CE/SE/EE.
  21. Give the Security deposit of amount and account detail/Bill Voucher number.
- All the documents must be in true certified copies by concern PIO.

Period from which information asked for: 2022 to 2023.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, observes that FAA has not disposed of the first appeal filed to him by following statutory procedure laid down in the Arunachal Pradesh Right to Information (Appeal Procedure) Rules, 2005. So, this appeal case is decided and determined ex-parte as made known to them in the hearing notice.

*As laid down at para-38 of the Guidelines for the FAA issued by the GoI and the State Govt. OM No. AR-111/2008 Dated 21<sup>st</sup> August, 2008, adjudication on the appeals under RTI Act is a quasi-judicial function. It is, therefore, necessary that the Appellate Authority should see to it that the justice is not only done but it should also appear to have been done. In order to do so, the order passed by the appellate authority should be a speaking order giving justification for the decision arrived at.*

**Now Therefore**, the instant appeal case is remanded to First Appellate Authority. Therefore, the **FAA-Chief Engineer (CE) Electrical E/Z, Namsai District Govt. of AP.**, following the principle of natural justice, shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within two weeks from the date of receipt of this order i.e. **on or before 07.08.2025**

The appellant is at liberty to approach this commission:

1. If the Appellant is not satisfied with the information furnished to him by PIO based on the judgement order passed by the FAA.
2. If the FAA has denied the requested information based on specific exemptions/ grounds provided under the RTI Act, 2005.
