<u>ORDER</u>

The PIO-cum-Executive Engineer, PWD, Naharlagun Division, Papumpare District, Govt. of Arunachal Pradesh, found absent for the consecutive 2nd time during the hearing, without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

The PIO absent consecutively 2nd time today, despite of notices being issued to the PIO on 13.12.2024 and 04.04.2025. The absence of the PIO consecutively has compelled the Commission to secure the attendance of the PIO to hear the appeal against him in the court of the Commission.

Taking serious note of the absence of the PIO for the 2nd consecutive time despite summons being issued to him, the Commission hereby orders as follows;

- To issue bailable warrant of arrest to the PIO-cum-Executive Engineer, (PWD) Naharlagun Division, Papumpare District, for securing his attendance in the Third Hearing of this appeal, which is on 30th day of October' 2025 at 10:30 AM.
- To issue notice to the Officer-In-Charge, Naharlagun Police Station, for executing the bailable warrant of arrest and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on 30.10.2025, at 10:30 AM, without fail, before this court.

- v) Notice for the next date of hearing need not be served to the Appellant as he is present during the hearing today.
