ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri John Tara Bakey, Yupia-II, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO, State Council for IT & E-Governance (Department of Information Technology and Communication), Itanagar, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 12/06/2024 regarding appointment of Director, officers & staff.

2). **The 2nd hearing was held on 14th October' 2025 (Tuesday) at 1100 hrs.** Ms Namgey Wangmu, Deputy Director (IT)-cum- PIO, State Council for IT & E-Governance (Department of Information Technology and Communication), Itanagar was present the court hearing.

3). The PIO-Cum- Deputy Director (IT)-cum- PIO, State Council for IT & E-Governance (Department of Information Technology and Communication), Itanagar informed the Commission that documents available in their office were furnished to the Appellant.

4). The Appellant Shri John Tara Bakey was absent and it was assumed that he was satisfied with the information so furnished by the PIO. So, the case was disposed of.

5). The Appellant Shri John Tara Bakey, reported to the court 15 minutes after the case was disposed of. He requested the Commission for one more hearing and informed that he had come from Yupia-II in the morning hours to attend the court hearing but due to heavy traffic jam from Yupia road to Itanagar, he got delayed by 15 minutes.

6). **Though, the case had been disposed of, the Appellant is given the permission to file a fresh application in the same department but was also advised to seek specific information based on actual requirement.**

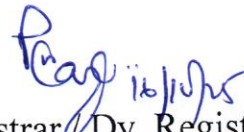
