Information sought:

The appellant filed an RTI application dated 14.02.2025 seeking all the relevant information in respect to C/o "Pradhan Mantri Krishi Sinchai Yojana" scheme executed in entire Lower Siang District during the financial year 2022-23 to 2024-25.

Particulars of sought information are given below: -

1. Furnish the certified Sanction Order Copy for all the project sanction under PMKSY.

2. Furnish the certified copy of all the work executed under PMKSY scheme for the Entire Lower Siang Dist. as per block wise.

3. Furnish the certified PRC (Permanent Residence Certificate) submitted by tender Participant issued by the Competent Authority regarding domicile status with the district as per Rule 4(ii) (b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.

4. Furnish the certified copy of Proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.

- 5. Furnish the certified copy of Technical Sanction done by the concerned Authority for the projects as per financial rules.
- 6. Furnish the certified copy of Utilization Certificate.
- 7. Furnish the details of Utilization of financial amount exempted after the financial bidding of the tender process of the projects is completed.
- 8. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
- 9. Furnish the certified copy of Criteria of eligibility for CPWD as well as non-CPWD contractors in this project.
- 10. Furnish the certified Progress Report of the projects in Physical and Financial section till date.
- 11. Furnish the certified copy of Completion certificate of the project.
- 12. Furnish the certified copy of Newspaper in which NIT was published (At least 3 newspaper name (one National & 2 Local)) along with date of publication of Newspaper, as per Government approved Order.
- 13. Furnish the certified Design and Scope of Work in the projects.
- 14. Furnish the certified copy of Work Specification of the projects.
- 15. Furnish the certified copy of documents submitted by tender participant for Technical Bid.
- 16. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
- 17. Furnish the Name of Officers and their Designation at the Time of monitoring the work.
- 18. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.
- 19. Furnish the certified copy of Contractor Enlistment Update reports (Civil/ Composite Category as per the nature of work), of tender participant and winning Firm.
- 20. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
- 21. Furnish the certified Integrity Pact submitted by the tender participant.
- 22. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dated. 01-08-2018 as per District Based Entrepreneurship Act, 2015 & 2020).
- 23. Furnish the certified documents submitted by tender participant and winning firm, i.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer and Chief Engineer, in the last 5 years ending last day of the month previous to the one in which the tenders are invited.

- 24. Furnish the certified copy of Acceptance letter for Tender work by the Executing Agency to the tender Winning Firm.
- 25. Furnish the certified copy of Work Order given to the Contractor by the Executing Department.
- 26. Furnish the Agreement Copy made between the Contractor and the Executive Agency for the projects mentioned above.
- 27. Furnish the certified copy of all Photograph of work items (colour photo) before starting of work and Photograph (colour photo) after completion of work.
- 28. Furnish the Geo Coordinate information before the start of projects and after the Completion of the project under PMKSY Scheme for the entire Lower Siang Dist.
- 29. Furnish the certified Payment Details (Cheque no., voucher, PFMS, DBT etc. (Which ever method is used for payments)) made to the contractor of the project till date.
- 30. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
- 31. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.
- 32. Furnish the certified Affidavit to invest cash up to (25% of tender value) submitted by the tender participant.
- 33. Furnish the certified copy of Total land of area that is irrigated under this Scheme.
- 34. Furnish the certified copy of Improvement percentage of access of water to the farm and extend cultivable land under quaranteed irrigation (Har Khet Ko Pani) of the beneficiaries.
- 35. Furnish the certified copy of appropriate technology and practices to make the greatest use of water source, distribution and efficient usage of the water.
- 36. Furnish the certified copy and Details of the land Owner where the PMKSY works has been executed.
- 37. Furnish the certified copy of NOC obtained from the concerned land owner where the projects have been executed.
- 38. Furnish the certified true copy of PMKSY Implementation Guidelines.

Order of the 1st hearing- "The Commission observes that the FAA – Chief Engineer, WRD (WZ) has heard and disposed of the appeal case on 23.04.2025 directing the PIO to furnish required information to the appellant within 20 days from date of hearing. The appellant is failed to get a response from the PIO within the stipulated period. Therefore, the Registry of the commission has referred back the appeal case vide letter dated 17.06.2025 to the FAA and directed to re-adjudicate the First Appeal, taking due care to verify that judgement order issued by him has been fully and properly implemented by the PIO within specified time period, prior to the disposal of the appeal case. There is no record of any tangible action taken by the FAA for implementation of his judgement order by the PIO. The PIO is directed to furnish the information to the appellant before next date of hearing."
