ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Smt. Bengia Rina & Shri Bengia Tani for non-furnishing of 16(sixteen) point information regarding the c/o Community Hall at new Bazar, Koloriang by the PIO, o/o the Executive Engineer (PWD), Sangram Division, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.10.2024.

This appeal was heard 3 (three) times on 11.06. 2025, 16.07.2025 and 01.08.2025.

On 16.07.2025 the representative of the PIO who attended the hearing was directed to furnish the requested documents in complete and satisfactory form to the appellant and report the compliance thereof in the hearing on 01.08.2025.

On 01.08.2025 the representative of the PIO, Shri Bini Tare is present with the documents but one of the appellants, Shri Bengia Tani appeared through the VC despite order of this Commission to appear in person.

This Commission after hearing the parties, directed the appellant to collect the documents from this Commission's office and intimate this Commission of the receipt of the documents and his satisfaction.

In compliance with the direction of the Commission, the appellant collected the information from this Commission but complained vide his letter dt.07.08.2025 that the following information/documents have not been furnished by the PIO:

1. Completion letter/certificate from the contractor to agency;
2. UC;
3. Cheque leafs (Agency to contractor)
4. Authorisation copy from higher authority and
5. Work order copy.

This Commission holds that it is the bounden duty of the public authority under the RTI Act that an information seeker is provided with the requested information correctly and satisfactorily and in a time bound manner unless the information requested are exempted under any of the clauses of section 8(1) of the RTI Act 2005. But on perusal of the points on which the information /documents have been sought by the PIO, it is found that the requested information are not covered by any of the exemption clauses. As such the PIO is directed to furnish the left out information as listed in the preceding paragraph within 2(two) weeks from the date of receipt of this order and the appellants are also directed to intimate the receipt of the documents and their satisfaction or otherwise therewith within one week thereafter failing which this appeal shall stand closed without further notice.
