The appellant filed an RTI application dated 24.08.2023 seeking following information pertaining to an RE/BE-2022-23

Details of Information required.

- Furnish total Fund allocation in the financial year 2022-23.
- LOC of all schemes.
- Furnish sanction order copy.
- Progress report.
- With details with photo copy of ware before during and after.
- Payment details with measure book (MB).
- Copy of notice Inviting Tender (NIT).

- h. Name of the tender board member with signature.
- i. Name of technical officer of site with their portfolio.
- j. No of firm participants with their firm details and documents.
- k. Supplied all the documents with CTC.

Period: 2022-23.

Relevant facts emerged during hearing:

Previous Hearing:

First : 14.11.2024 - (Both the PIO & Appellant was present).
Second : 20.01.2025 - (PIO absent & Appellant present).
Third : 28.04.2025 - (PIO absent & Appellant present).

Order of the 3rd hearing- *"The commission observes that PIO has not furnished any information to the appellant and remained absent consecutively for last two hearings including today. Thus, there is no proof that the PIO has received the SHOW CAUSE NOTICE dated 23.01.2025 or not. The appellant is directed to serve a copy of this order with SHOW CAUSE NOTICE dated 23.01.2025 to the PIO and the Executive Engineer, RWD, Daporijo, and obtain written acknowledgement and submit a copy of it to this commission."* (A copy of SHOW CAUSE NOTICE dated 23.01.2025 enclosed)

The following were present.

Appellant : Present. He states that a copy of show cause notice was served to the PIO in compliance of this commission's order dated 28.4.2025. He further states that some information has been received which does not conform to the item of information sought in RTI application.

Respondent PIO : Shri Taku Raji AE / APIO represented the PIO. He states that he is not aware of the show cause notice served to the PIO. He states that all available information have been furnished to the appellant.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that the PIO has not explained / replied the Show Cause notice served to him. He has furnished some information documents to the appellant without specifying the pointwise reply as per RTI application in form A. The appellant is directed to file a written submission to the PIO with statement of specific shortfall as per original RTI application within one week from the date of issue of this order. The PIO shall furnish the information within ten days upon receipt of such written representation from the appellant under intimation to this commission. The PIO shall also explain / or reply the show cause notice served to him.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. If no compliance report is received within stipulated time, this appeal case shall stand closed.
