The appellant filed an RTI application dated 09.07.2024 seeking information regarding District Mineral Foundation Trust and its bank operation details.

Details of information required:

- Whether any notification / order has issued for formation of District Mineral Foundation Trust under the administrative jurisdiction of DC, Yupia or not? If so, provide a copy of such notification/order.
- In which schedule bank the District Mineral Foundation Trust (DMF), Yupia's account opened. Provide the name of the bank and photocopy of front page of

- the passbook showing the details features of account number and cheques issued by the bank in this behalf.
- c) How much fund / amount has been accumulated till Date in the trust account? Provide the photo copy of the latest updated passbook showing the amount.
  - d) How many times DMF meeting was conducted and what action was decided in the meeting. Provide the minutes of the meeting.
  - e) Provide the expenditure incurred for the conducting the meeting.
  - f) Till date how much amount from DMF account, Yupia has been spend for the affected areas and affected people. Provide the detail as per the detail of DMF trust meeting.
  - g) Since opening of the DMF account number, whether said account number ever changed or altered? If yes, provide the reasons for change and letter of the DC, Yupia, for change of the said account number.

**Relevant facts emerged during hearing:**

Previous Hearing:

First Hearing : 13.02.2025

In first hearing ordered as: *"The Commission has directed the appellant to examine the adequacy of the information furnished to him within one week from the date of issue of this order. He (appellant) shall file a written submission of any shortfall in the information furnished to him to the PIO clearly specifying the item of shortfall within two weeks from date of issue of this letter i.e 27.2.2025 under intimation to this commission."*

The following were present.

**Appellant** : Adv. Ashomi Linggi represented the appellant. He states that some additional information has been received and need some more time to verify its correctness. The appellant has submitted an application dated 13.5.2025 to this commission seeking reopen of the appeal case.

**Respondent PIO** : Absent.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing the party and perusal of the records, observes that the appellant has not complied the order of this commission court order dated 13.2.2025 wherein he was directed to file written submission to the PIO if there is any shortfall in the information already furnished to him. Instead, he has written aforesaid application to this commission. A copy of this application be furnished to the PIO. The PIO shall furnish reply of this application and any additional information within the purview of RTI application in form A directly to the appellant within one week from the date of issue of this order under intimation to this

commission. The appellant shall collect such reply from the PIO within the stipulated time and submit a report to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. If no compliance report is received within stipulated time, this appeal case shall stand closed.
