## **Appellant**

: Present. He states that irrespective of order issued by the first appellate authority the PIO has not furnished information to him.

### **Respondent PIO**

: Present through VC. He states that appellant was asked to deposit the requisite fee for furnishing the information vide a letter dated  $21^{\rm st}$  April 2025. The information document is kept ready with him.

On interjection the appellant states that the RTI application was received at PIO's office on 14th February 2025. Prescribed time period of 30 days since filing of RTI application was already over when PIO has written to him for remittance of requisite fee. The PIO did not further contest on this.

#### Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, hearing the parties observes that PIO did not deliver the information to the appellant irrespective of order issued on 06.05.2025 by the first appellate authority to do so. The PIO is directed to send the information documents to the appellant free of cost through registered post, under intimation to this commission, within one week from the date of issue of this order and keep track record of the postal delivery. The appellant shall file a written status report of full information received by him. If any shortcoming, the appellant shall file a written submission to the PIO specifying the shortfall within 10 days upon receipt of information under intimation to this commission. In case of no report received from the appellant within specified period this appeal case shall stands closed.

The hearing is adjourned. Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant.
