ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Kaya Parang Londa, Bank Tinali, Near King Cup Public School, Lowang Apartment, Itanagar Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-Cum-DFO, Govt. of A.P., o/o Divisional Forest Officer, Khellong Forest Division, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A dated 09/05/2023 regarding total fund allocated in CAMPA under CA, Activities in the Khellong Forest Department.
- 2). The 10th hearing was held on 5th August' 2025. Respondent Ms Suman Beniwal, IFS, the new PIO-Cum-DFO, Govt. of A.P., O/o Divisional Forest Officer, Khellong Forest Division, Balukpong West Kameng District, Arunachal Pradesh was present alongwith Shri Aduk Paron, the then PIO-Cum-DFO, Govt. of A.P., O/o Divisional Forest Officer, Khellong Forest Division, West Kameng District, Arunachal Pradesh now DFO, Lohit Forest Division, Tezu. The Appellant Shri Kaya Parang Londa was present.
- 3). The Commission expressed displeasure about lack of response on the Show Cause Notice of 10th July' 2025. Shri Adok Paron, the then PIO-Cum- DFO, Khellong stated that he had not received any Show Cause Notice and that he was already transferred to Lohit Forest Division, Tezu after handing and taking over charges with the new incumbent on 20th May' 2025.
- 4) Ms Suman Beniwal, IFS, the PIO, informed that they had not received the hearing notice which was to be held on 8th July' 2025 and therefore, they did not attend the hearing on the above mentioned date. She tendered an apology to the Commission for the non-attendance which was unintentional. She had also explained her absence through their office letter No. KD/33/2021/Campa/5029-30 Dtd Bhalukpong, the 21st July' 2025 which had been received by APIC.

- 5). The PIO stated that available documents had already been furnished to the Appellant and as per the Commission's direction she had brought an "AFFIDAVIT" duly signed by the NOTARY Public and submitted the same before the Court for onward submission to the Appellant.
- 6) Base on the PIO's correspondence and on submission of the AFFIDAVIT, the Commission observed it fit to be dispose of the case.

Hence, the case is disposed of.
