ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Jollang, Near Himalayan University, Itanagar, PO /PS Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/06/2025 regarding detail of information of Mandal, RK, & SK.
- 2). The 1st hearing was held on 25th November' 2025. Ms Byabang Naemeh, PIO-cum-DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Ms Bengia Mama were present.
- 3). The PIO submitted that in her office record complete information as sought by the Appellant were not available. In this regard a letter had been written to the Directorate of Land Management, the parent department, but till date no reply had been received. A copy of the letter was sent to the Appellant too to facilitate follow up action.
- 4). The Appellant informed that she had not received such a letter till date.
- 5). The Commission directed the PIO to once again write to the Land Management Department under intimation to the Commission and also furnish a copy to the Appellant.
- 6). The Commission also hereby directs the authority of the Land Management Department to furnish information to the DLRSO Capital Complex or directly to the Appellant within fifteen days from the date of issue of this order.

- 7). The Commission asked the Appellant to approach the PIO or the concerned authority of the Land Management Department and collect information. After receipt of information the Appellant was directed to intimate her satisfaction or dissatisfaction by 24th December 2025.
- 8). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above date given, the case would be disposed of.
