ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu for non-furnishing of below mentioned information by the PIO, o/o the (DFO) Dibang Valley Roing, District Lower Dibang Valley, Govt. of Arunachal Pradesh, Naharlagun as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 09.10.2024.

This appeal was heard for 2(two) times on 02.05.2025 and 30.05.2025.

In the hearing on 30.05.2025 the appellants were absent but informed by one of the appellants that due to health issue he will not be able to attend the hearing but the PIO was present through VC who submitted that the requested documents has been dispatched to the appellant via speed post on 28.05.2025. The copy of letter dt.27.05.2025 forwarding the documents was also furnished to this Commission during the course of hearing.

This Commission heard the PIO and directed the appellants to intimate this Commission of the receipt of the documents and their satisfaction therewith within 2(two) weeks from 30.05.24 for further consideration of the appeal.

In compliance with the order of this Commission, one of the appellants, vide his letter dt.13.06.2024, has informed that he has received the documents on 12.06.24 but the documents has been provided in ambiguous manner and not as per their RTI application. He, therefore, requested for hearing this appeal again.

This appeal was, therefore, listed again on 18th July, 2025 with the direction to the appellants to submit in writing the specific query which needs to be clarified or furnished properly by the PIO.

In today's hearing, however, neither the PIO nor the appellant appeared. The appellant also did not comply with the direction of this Commission contained in the order dt. 17.06.2025. But one of the appellants, Shri Riya Taram had sent a message through Shri Tamchi Gungte that due to a hearing of one of their appeals in the FAA court, they will not be able to attend the hearing in this commission.

The appellants are directed to submit the details of shortcomings/in the replies specifically within 1(one) week from the date of receipt of this order to enable listing of this case for further consideration, if required, failing which this appeal shall stand disposed of and closed.
