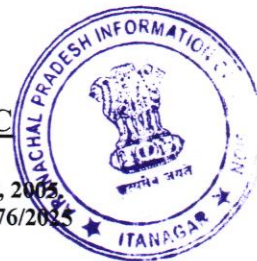

ORDER

The 2nd hearing held on **31st July, 2025** related to the **APIC No-76/2025**. The Appellant Shri Tamchi Gungte is present.

The PIO-cum-EE, RWD, Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh is represented by his APIO, Shri Sachin Jerang (Junior Engineer) during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has not yet been furnished complete information(s) from the office of the PIO.

Heard the APIO;

The APIO stated before the Commission that he has brought all the information(s) to the court of the Commission to be furnished to the Appellant.

The Commission orders;

The Appellant is ordered to receive the information(s) from the APIO and after verifying the information(s) provided to him whether the information(s) are complete or not to let the Commission know of the same and to ascertain the same from the Appellant a next date of hearing is to be fixed.

The Commission observes;

Going through the information(s) provided by the APIO it is found that the information(s) applied by the Appellant in his Form-A under Serial Nos. 3, 7, 9 and 10 have not been furnished by the PIO. The information(s) pertaining to Serial Nos. 9 and 10 the PIO shall provide the DPR as well as Rural Road Manual to the Appellant in soft copy.

The Commission hereby orders;

- (i) The Appellant to verify the documents and to let the Commission know that the information(s) have been received completely or not, on or before the next date of hearing and to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.

- (ii) The PIO to provide the information(s) pertaining to Serial Nos. 3, 7, 9 and 10 to the Appellant and to be present in the next date of hearing to ascertain if the complete information(s) have been provided to the Appellant or not, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (iii) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 11th November, 2025' at 2:30 PM (Evening).


