ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu for non-furnishing of below mentioned information by the PIO o/o ,the Executive Engineer (PWD), Roing Division, Distt. Lower Dibang Valley, (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 28.12.2024.

A) Particulars of information: To furnish all the Relevant Information against Name of Scheme/Work list under funding head of * SADA (2016-24) which listed out from your earlier furnished RTI documents in Annexure Form A.

B) Details of information Required:

1. Give the Name of Scheme/Work list/DPR Copy/Coloring Photocopy Geo-tag Report of every work site.

2. Give the copy of work order/sanction order copy with annexure details moods of contractor/firm payment like Cheque leaf/demand draft/banker cheque /RTGS slip by department as per the Name Scheme/work list wise.

3. Give the Money Receipt of Contractor/firm Payment list as according to the name of Scheme/Work list wise with their Signature and contact number.

4. Give the Xerox copy of Firm/Enterprise Trading Licence.

5. Give the first & final bill copy of all the works with enclose details of payment like Cheque leaf/demand draft/banker cheque/RTGS slip of contractor/firm by department as per the Name of Scheme/work list wise.

6. Give the billing detail sheet/scheme detail Sheets copy of work wise.

- 7. Give Xerox copy of Cheque leaf/Banker Cheque/RTGS/billing Challan/voucher of Contractor/firm bill payment by department as per the Name of Scheme/work list/work order wise.
- 8. Give the measurement/Cashbook Statement in work wise.

9. Payment List of Contractor/firm/Hand receipt with payees name.

10. Give the various name of deduction amount from contractor/firm bill payment as percentage as per Govt. guidelines.

11. Give the Certified Coloring Photocopy of all the Work Sites by Concern PIO.

12. Give the Coloring photocopy/videographer of every work site which may be Before Starting of work/Starting of work and ending of work.

13. Give the NOC copy of ZPC/ZPM/GPC/Gaon buras/buris of concern Segment/block.

14. Give Name of Officers & Officials with their Signature/Seal, Who hold the DDO Power to approved the financial matter or handled the work.

- 15. Give details of Enlistment of contractor as per work department Rules Act 2008.
- 16. Give details of proprietor of firm / registration of certificate.
- 17. Give Money deposited Challan of the Govt. account against GST/Royalty by department/Firm/Enterprise.
- C) Period from which information asked for :2016-2024.

Brief facts and decision:

Records emerging from the appeal disclose that the appellants, Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Chief Engineer, PWD, Govt. of A.P, Eastern Zone, Namsai, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 14.02.2025. However, the appellants having failed yet again to obtain the information preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 18.03.2025.

This appeal is, accordingly, listed today on 1st August, 2025. But the appellants are absent while Shri Vikash Bagang, JE, o/o the PIO representing the PIO is present in person and brought the requested information /documents.

Since the appellants are absent, this Commission is of the view that they are not interest in the information any longer and resultantly, this appeal stands closed as such.
