## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of Rural Work, Longding Division, District Longding, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Konsa.
- 2). The 2<sup>nd</sup> hearing was held on 11<sup>th</sup> November' 2025. Shri R.W. Zimik, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh, was absent. The Appellant Shri Wangnon Wangnow appeared before the Court through video conferencing.
- 3). The Appellant submitted that till date the PIO had not furnished correct and complete information as sought for in the Form-A dated 05/02/2025.
- 4). The Commission viewed the absence of the PIO, without any justifiable reason, seriously.
- 5). The Commission hereby directs **Shri R.W. Zimik**, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh to **SHOW CAUSE** as to why Penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005, failing which disciplinary action shall be recommended under Section 20 (2) of the RTI Act, 2005.

- 6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO found absent the Commission will initiate penal action under section 20(1) of the RTI Act, 2005, and issue Arrest Warrant under section 18 (3)(a) of the RTI Act, 2005 to compel attendance. In case Appellant is found absent the case shall be disposed of without any further notice.
- 6). The next date of hearing is fixed on 9th December 2025 (Tuesday) at 1100hrs.
