ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu for denial by PIO, o/o CF/Field Director, Namdapa National Park & TR Miao, Changlang of the of 22 (twenty two) point information regarding the release of Fund amounting to Rs.266.733 as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 09.10.2024.

This appeal was listed and heard for 2 times earlier on 02.05.2025 and on 02.07.2025.

On 02.05.2025, this Commission, upon hearing the parties, had directed the PIO to furnish the documents through a messenger and the appellants were also directed to inform this Commission of the receipt of the documents within one week of the receipt of the same

In compliance with the order of this Commission, the PIO, vide letter dt.13.05.2025 had furnished the requested information through a Special Messenger, Shri Munna Sharma from the o/o the PIO with intimation to this Commission.

Shri Riya Taram, one of the appellants, vide his 26.05.2025 addressed to this Commission, had, however, expressed his dissatisfaction with the documents so furnished to him saying that the documents were not furnished as per his RTI application in Form-A and therefore, pleaded for hearing the appeal again. This appeal was, therefore, heard again on 02.07.2025 wherein the PIO appeared through VC again but the appellant was absent who informed through whatsapp that he is undergoing medical treatment and requested for adjournment of the hearing.

The PIO, reiterating his statement in the letter dt.13.05.2025 regarding the particulars of requested information as "**general nature and not related to specific items of work**", pleaded for direction to the appellant to be specific in seeking information on the release of funds.

As prayed for by the PIO, this Commission had directed the appellant to mention and explain clearly on or before 18.07.2025, the specific points on which information/replies have been missed out /found incomplete and it was made clear that this appeal shall be closed without further notice if he fails to comply with the order.

The hearing was thus, adjourned to 01.08.2025, today wherein the PIO is present in person but the appellant is absent without any information.

Heard the PIO who submitted that though the appellant did not inform his office of the specific points on which the replies were not satisfactory, he had dispatched the left out documents to the appellant through post office in support of which he produced a copy of letter dt. 23.07.2025 forwarding the documents with the dispatch record from the post office. This Commission, on tracking the dispatch record, found that the consignment is still in transit (RKM post office) in view whereof, this Commission decides to allow the appellant 1(one) week time to intimate this Commission the receipt of the documents and his satisfaction therewith. It is made clear that if the appellant fails to comply with this order again, this appeal shall be closed without further order.
