

ARUNACHAL PRADESH INFORMATION COMMISSION, APIC

An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-109/2025

Shri Mamu Sono -V/S- PIO-Cum-Director SPD, ISSE, Itanagar P/Pare District A.P.

ORDER

The 2nd hearing held on <u>29th July, 2025'</u> related to the <u>APIC No-109/2025</u>. The Appellant Shri Mamu Sono is present.

The PIO office of the Director SPD, ISSE, Itanagar, Papumpare District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has not yet been furnished any information(s) from the office of the PIO.

Heard the PIO:

The PIO stated before the Commission that all the information(s) are ready to be furnished to the Appellant. On 4th March' 2025 he has written to the Appellant to collect the information(s) from the office of the PIO, but the Appellant has not responded till date.

After hearing both the parties and going through the Form-A application of the Appellant: the Commission hereby orders:-

- The Appellant to personally collect the information(s) sought, from the office of the PIO. After collecting the information(s) let the Commission know whether the information(s) have been completely provided to him or not and to ascertain the complete receipt of the information(s), the Commission hereby fix another date of hearing.
- ii) The Appellant to be present in person or through online mode in the next date of hearing without fail, failing which this instant Appeal will be heard and determined ex-parte.
- The PIO office of the Director SPD, ISSE, Itanagar, Govt. of Arunachal Pradesh to be present in person or through online mode in the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of the RTI, Act, 2005.

iv) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 6th November, 2025' at 10:30 AM (Morning).
