ORDER

- 1). This is a complaint under Section 18(1) of RTI Act, 2005 filed by Shri Gungli Tacho, ESS Sector, Itanagar, Narba Colony P.O / P.S Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DLRSO, Govt. of A.P., Department of District Land Management, Palin, Kra-Daadi District, Arunachal Pradesh, as sought by the complainant under section 6(1) of RTI Act, 2005 vide Form-A Dated 16/06/2025 regarding Frontier Highway, Huri – Taliha stretch (Package-III).
- 2). **The re-scheduled 1st hearing was held on 20th January' 2025.** Shri Pudam Takar, PIO-cum-DLRSO, Govt. of A.P., Department of District Land Management, Palin, Kra-Daadi District, Arunachal Pradesh was present. The Complainant was represented by authorized Advocate Charu Bosco.
- 3). The representative of the Complainant submitted that out of five points information sought, two points had been furnished. The PIO had not furnished list of owners' name, billed amount details with owners' name and copy of Cheques.
- 4). The PIO informed that under 11 & 19 of the LAR Act' 2013 name of the land owners were published in the news papers and ample opportunity were provided for any objection. A final meeting was held under the Chairmanship of ADC Tali, thereafter compensation was released to beneficiaries after finalization.
- 5). The PIO also submitted that a prohibitory direction from Secretary Land Management, pertaining to supply of any information related to Military had been issued. Also, the department had prohibited disclosing the amount related to the project. However, any other information could be provided to the Complainant.

6). The Commission directed the PIO to furnish all the information as sought for by the Complainant except details pertaining to Military land within thirty days from the date of issue of this order. The Commission asked the Complainant to cooperate with the PIO in sorting out the issue amicably and get all the necessary information as required.

7). The Commission also asked the Complainant to intimate his satisfaction or dissatisfaction after receipt of information.

8). The next date of hearing would be decided on the basis of intimation from the Complainant. In case the Complainant failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.
